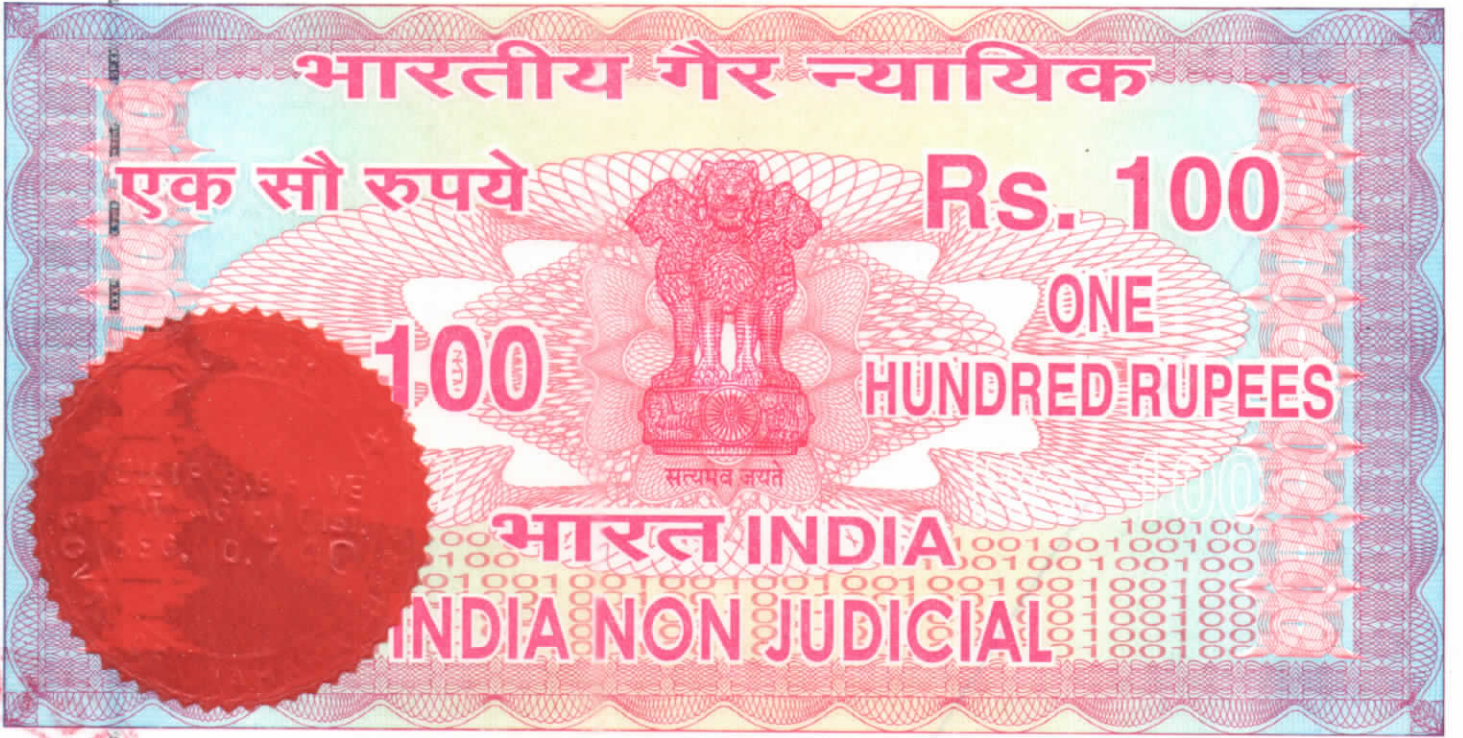

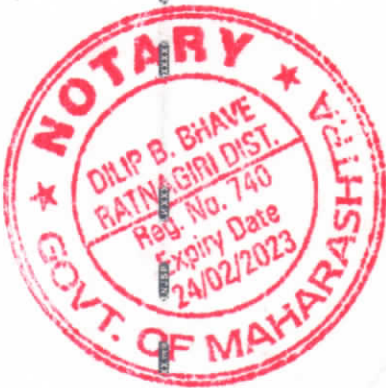

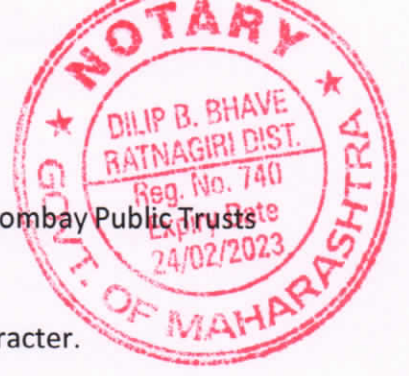


AFFIDAVIT


