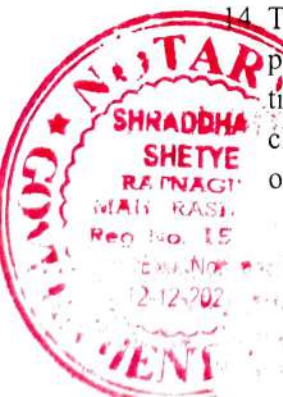

1. Any future changes in the medium and school location etc. prescribed by the institution for school permission can't be done.
2. If the school is started in a place other than the place where the government has given permission, government's permission will automatically be deemed cancelled.
3. Permission granted to establish a school from academic year 2018-19 in advance.
4. Classes other than those allowed in the academic year 2018-19 will not be permitted.
5. If permission is not initiated by the management within 18 months from the date of receipt, then cancellation is allowed.
6. Right to education as per rules, norms, as well as the child's free education is obligatory to comply with all provisions under the Act of 2009.
7. All permissible information on self- help basis for the information of all the people should be displayed in the front of the school building, which the new school / upgrading class will be obliged to display a board.
8. Recognition under the Maharashtra Self- help school (Establishment and Regulation) Act 2012, the school will not be relocated to other places in the future.
9. Permission under the Maharashtra self- help school (Establishment and Regulation) Act 2012, the required schools should submit separate registration as self- help/ class while filling the information in UDISE.
10. Physical facilities should be available in new/ upgraded schools as per Government decision dated 29/6/2013. Adherence to all standards set forth in RTE Act 2009 with respect to primary school is mandatory.
11. Regular rules for improving the educational fees incurred in school as well as recurring from time to time has to be charged. However, the educational fees should not be excessive. Except for unpaid tariffs action will be taken.
12. To run the above classes on a regular basis without any subsidy as per the provisions of the Act must be financially capable. In the future as these categories are approved on a permanent non – grant basis, no subsidy and financial assistance will ever be provided by the Government.
13. The building and campus of the school should be clean, safe and secure.
14. The competent staff required for academic and professional qualifications as prescribed by the Government from time to time. The Government shall from time to time be subject to the pay scales and condition of service. The appointed teacher's class must be approved by the competent authority and according to the homopwner of the staff provided the organization.

15. Facilitation of physical facilities management at the institute, etc. It is required that the school is well maintained. Government decision has to address the criteria for the basic facilities provided on 29.6.2013 is required.
16. Institution should be implemented in this school from time to time which should include implementation of the syllabus, textbook / evaluation methods of school and co-curricular programs and activities with provision of all the necessary facilities.
17. The institution shall implement the prescribed records for the students/ staff of the school and must be kept in the most reliable format.
18. The institution/ school has to provide the terms of primary school code, staffing services in private school of Maharashtra. The rules of the procedure, the provisions of Rule 1949 as well as the order issued from time to time by the Government must be complied with.
19. As per Government decision dated 3/11/2009 and as per the order of the supreme court, the school building is national. The building code is subject to approval of the building.
20. The curriculum in which the school has sought permission to engage with the Board should be to the Deputy Director of Education in accordance with the procedure laid down in the prescribed pattern for the affiliation of Course Board will apply.
